

Sikkim WCD dept organises camp for persons with disabilities



GANGTOK, DEC 25 --/ The Women & Child Development Department of Sikkim government successfully organised a comprehensive disabled camp for Gangtok district at Singtam District Hospital. The event, which took place amidst an atmosphere of inclusivity and care, drew a large number of beneficiaries from all five Block Administrative Centre (BAC) Gram Panchayat Units (GPUs) and the Gangtok Municipal Corporation (GMC).
