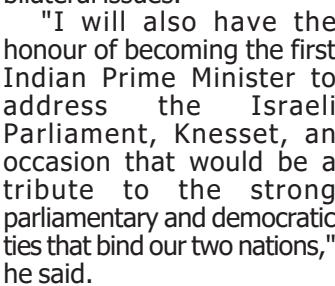

sphere. At the centre of this outreach is the party's Rajya Sabha MP John Brittas, widely seen as devising a strategy to harness the persuasive power of cinema and literature. The most high-profile move was bringing in superstar and Dadasaheb Phalke award winner Mohanlal, who was 'flown' out of a shooting schedule in Thodupuzha for a two-day programme culminating in a televised

interaction with the Chief Minister. Directed by filmmaker T.K. Rajeev Kumar, the exercise followed structured discussions on tone and content, underscoring the meticulous planning behind the optics. Significantly, this came months after Mohanlal and Kamal Haasan skipped the state government's "Extreme Poverty Free" declaration ceremony held on November 1, 2025, in Thiruvananthapuram.

Gadkari has assured Manipur Chief Minister Bhanu Prasad Hemchandra Singh of possible support from the centre for the development of national and state highways in the state, officials said on Wednesday. An official of the Chief Minister's Office (CMO) in Imphal said that the Chief Minister, accompanied by his Deputy Chief Ministers -- M. K. Mahanta and Joshi Dikho -- will visit Gadkari at his office in New Delhi on Tuesday night.

During the meeting, the Chief Minister briefed the Union Minister on the status of various ongoing and proposed road infrastructure projects in Manipur. Singh also apprised the Union Road Transport and Highways Minister to give special attention to the state's proposals for elevated highways and the strengthening of National Highways to improve connectivity and logistics.
