A part of the amount earmarked under the head of investor education and incentive expenses may be allocated towards payment of additional commission to distributors, in accordance with the structure outlined below.

1. New individual investors (new PAN) from B-30 cities;

2. New women individual investors (new PAN) from both T-30 and B-30 cities.

Payment of Additional Commission:

1. The additional distributor commission all be paid from the 2 basis points on daily net assets, mandated to be set apart annually by AMCs for investor education, awareness and financial inclusion initiatives, subject to adequate claw back.

2. Such commission shall be in addition to existing trail commission paid to the distributor from the scheme.

3. The additional commission shall be paid after completion of 1 year from the date of allotment of units. In case of SIP, the instalment amount realized during the year, will be considered for incentive amount at the end of the year.
