

Girganga Parivar Trust's Vision of 1,11,111 Water Conservation Structures Gets a Boost



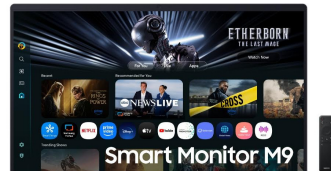

Rajkot, After a video of a customer creating a ruckus with stale cake at an outlet of Atul Bakery in Nanavati Chowk, Rajkot went viral, now the food department has taken action after receiving complaints of moldy bread at an outlet in the Pushkardham area. A video of a woman claiming that the sandwich bread has mold has gone viral. In it, the woman is threatening that my daughter has eaten four breads, if anything happens to her, I will close the shutters of your shop. After receiving a complaint in this matter, RMC has taken action to take samples.

According to the details available, a heated argument broke out between a customer and the shop owner at the outlet of Atul Bakery near Pushkardham Chowk in Rajkot on Thursday afternoon. The root cause of the argument was the moldy bread sold to a female customer. The woman reached the outlet of Atul Bakery and raised an uproar. She said that when she went home and started using the bread, she clearly saw mold in the bread packet. Greenish mold marks were seen on the bread.

The woman's angry video went viral. The woman

immediately returned to the Atul Bakery outlet. There, she expressed her anger against the owner and employees of the outlet. The woman showed the moldy bread sold

to the shop owner and demanded an immediate answer from him. In the video uploaded by the people present at the scene, it can be clearly seen how the greenish

mold has spread on the bread. The woman had started making this video from home and she also recorded her anger at the bakery in the video.
