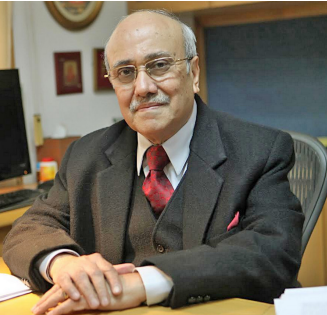


IRF FOR 5E APPROACH TO PUSH TOWARDS

Ventura expects Sensex level to reach 115,836 and Nifty 50 level at 43,876 by FY28. In a bear case scenario, Sensex is projected to reach 1,04,804 and Nifty 50 at 39,697 by FY28. Vinit Bolinjkar, Head of Research, Ventura said "In the last 10 years, Indian economy has demonstrated resilience and clocked highest GDP growth as a large economy despite global headwinds of NBFC crisis, Covid 19, Russia-Ukraine war and the recent uncertainty on Trump tariff. The risk mitigation influencers will outweigh the current challenges which will usher Indian GDP growth to 7.3% by FY30(E). We anticipate significant wealth creation aligned with India's structural reforms and macroeconomic stability."
