The purchase consideration included contingent consideration payable over two years based on Quant achieving certain financial targets in the year ended December 31, 2023 and December 31, 2024. Pursuant to the disclosures in the previous quarter, SSNA and the selling shareholders of Quant have concluded the amended agreement on May 18, 2025.
5. The above results have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on July 30, 2025.
6. Based on the financial performance of the Company, the Board at its meeting held today, approved an interim dividend of ₹ 1.25/- (-125 % on par value of ₹ 1/-) per share.
