The undersigned being Authorised officer of The Truhome Finance Limited (Earlier known as Shriram Housing Finance Limited) (hereinafter referred to as "TRUHOME FINANCE LIMITED" for the sake of brevity) is having full powers to issue this notice of sale and exercise all the powers of sale under Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act,2002 and the rules framed there under :-

1. You have committed default in payment of outstanding dues of Rs. 19,63,274/- (Rupees Nineteen Lakh Sixty Three Thousand Two Hundred Seventy Four Only) as on 10.01.2024 under reference of Loan Account No. SHLHIMMT0000056 with further interest at the contractual rate, within 60 days from the date of receipt of the said notice. Hence, on 12/01/2024 The Truhome Finance Limited(Formerly known as Shriram Housing Finance Limited) has issued Demand Notice Under Section 13(2) of the Sarfaesi Act,2002 to pay the above mentioned amount within 60 days. You have failed to pay the amount even after the 60 days.
2. Therefore, The Authorised Officer, in exercise of powers conferred under section 13(4) has taken Physical possession of the below mentioned properties described herein below under the Sarfaesi Act on this 06th Day of April, 2024.(06/04/2024).
3. Therefore The Truhome Finance Limited in exercise of its rights granted under the Act and Rules, notice is hereby given under Rule 8(6) to you pay full foreclosure amount with costs, expenses, interest & etc within 15 days from the date of this notice, failing which The Truhome Finance Limited shall proceed under the Act with the sale of the Secured

7. Earnest Money Deposit (EMD):

- a. The bid shall be accompanied by the EMD as specified in the public sale notice/tender document. Earnest Money Deposit (EMD) shall be deposited through RTGS/NEFT/DD as detailed mentioned in public notice.

- c.
