Haresh Dihora, son of the victim Arjanbhai, Vijay Mangukhiya, Jay Virani, Abhin Kalthiya, Ghanshyambhai Mordia and other leaders were present in this meeting.

A huge crowd of villagers gathered to watch the reconstruction of Raju Ulwa. Then at 6.30 pm, accused Raju Uleva was brought to the meeting place. From where a reconstruction was done to the scene of the incident, which was 1.5 km away. During this, the accused was walking crookedly with his head down. At this time, a crowd of villagers and Patidar community had gathered.
