He also launched several projects for the youth in Bihar, calling them a "guarantee of a bright future". The Kaushal Deekshant Samaroh is the fourth edition of the National Skill Convocation, which was organised in accordance with the Prime Minister's vision, where 46 all-India toppers from Industrial Training Institutes (ITIs) under the Ministry of Skill Development and Entrepreneurship will be felicitated.

During this, the Prime Minister also addressed the

Bihar youth virtually, aiming to highlight key development plans focused on education, skills, and employment.

His address was attended by youth in a packed auditorium in Patna, where Bihar Chief Minister Nitish Kumar and Deputy Chief Minister Samrat Choudhary were also present.

Addressing the event, he extended wishes to the ITI students and said, "Just a few years ago, our government started a new tradition of large-scale convocations for ITI students. Today, we are all witnessing another milestone in this tradition... Today's ceremony symbolises the importance India places on skills. Today, two more major education and skill development projects have been launched for youth across the country."

"Till the time we do not give dedication to hard work, and the hardworking people do not get respected in society, then they might not feel good about themselves. This event is an initiative to change the mindset. We follow the path of 'Shramev Jayate, Shramev Poojayate'. With this feeling, the students from the ITIs should also get confidence. This is a path to a bright future," he added.

Kerala Education Minister orders inquiry after Palestine mime performance was stopped



Kasaragod, Kerala's Education Minister, V. Sivankutty, on Saturday, ordered an inquiry after a mime performance at the school was halted, and the festival was rescheduled, asserting that the state stands in solidarity with the children and families in Palestine. The event was taking place at Kasaragod Kumbala Higher Secondary School.

Minister Sivankutty instructed the Director of Public Education to carry out an immediate investigation and submit a report on the incident.

"It is important to understand exactly why the performance was interrupted and why the festival was altered," said the Minister.

The minister emphasised Kerala's consistent stance on international human rights issues.

"Kerala has always taken a firm position against the genocide being carried out by Israel in Palestine. We stand in solidarity with the children and families being persecuted there. It is not acceptable for any authority to prevent students from expressing themselves on such matters," he stated. Clarifying the government's position on student rights and creative expression, Sivankutty added, "I want to make it clear that students at Kumbala School will be allowed to perform the same mime on stage. Creative expression in educational settings must be encouraged, especially when it reflects social and global concerns."

The minister's statement underlines the Kerala government's commitment to freedom of expression within schools, while also maintaining awareness of sensitive social and political issues.

He reiterated that the halted performance does not reflect the state's official stance on the Palestine issue but is instead a matter to be clarified through investigation.

The incident has sparked discussions on the role of educational institutions in allowing students to engage with global issues through cultural activities.

The investigation and subsequent report by the Directorate of Public Education are expected to provide further clarity and ensure that students' opportunities for creative expression are protected in the future.

Issue of who holds CM's post is internal matter of Congress party: Siddaramaiah

Belagavi (Karnataka), Commenting on the statements by BJP leaders on leadership change in Karnataka, Chief Minister Siddaramaiah came down heavily on them on Saturday and stated that the issue of who holds the Chief Minister's post is an internal matter of the Congress party.

He was speaking to reporters at Belagavi airport, where he had reached to inaugurate the super-speciality hospital at Belagavi Institute of Medical Sciences on Saturday.

In response to a question about the Leader of the Opposition R. Ashoka and BJP MLC C.T. Ravi's remarks about the Chief Minister's post, Siddaramaiah stated, "The issue of who holds the Chief Minister's post is an internal matter of the Congress party. The BJP need not concern itself with it."

Earlier, Leader of the Opposition in the Assembly R. Ashoka stated on Friday that the power-sharing arrangement between Chief Minister Siddaramaiah and Deputy Chief Minister, State Congress President D.K. Shivakumar, is "hundred per cent true."

Ashoka claimed, "I have stated that there will be a November revolution and Siddaramaiah will become the outgoing CM. I stand by my words. Within November and December, there will be a revolution. There is no doubt. The power-sharing arrangement is hundred per cent true, and bickering has already started."

When asked about reports that Chief Minister Siddaramaiah had stated he would remain CM for five years, Congress General Secretary K.C. Venugopal responded on Saturday, "Every time I come to Karnataka, the same question and the same agenda is raised. It is the Congress party that has the authority to decide what should happen within our party. Leave that decision-making power to us. The party will take a decision when necessary."

Responding to the allegations by R. Ashoka that NDRF funds were being diverted for guarantee schemes, CM Siddaramaiah further slammed the BJP stating that, "The success of guarantee schemes has caused anxiety within the BJP. The Congress government has stood by its word and is implementing the guarantees without fail."

CM Siddaramaiah clarified



that NDRF grants were not being used for guarantees.

"The BJP views everything through a jaundiced eye, and the success of our guarantee schemes has unsettled them. Our guarantees are being emulated in several states including Bihar, Delhi, Maharashtra, Madhya Pradesh, and Haryana. Prime Minister Modi had claimed that implementing guarantees was impossible. But the Congress government has stood by its word and is delivering the guarantees without fail," CM Siddaramaiah said.

Expressing happiness on the inauguration, Chief Minister Siddaramaiah said, "It is a matter of joy that the super-speciality hospital at Belagavi Institute of Medical Sciences (BIMS) in Belagavi, for which the foundation stone was laid in 2017, has now

been inaugurated. During the BJP's tenure, this project did not materialise. The hospital's management has not been handed over to any private organisation."
