

WESTERN RAILWAY CONTINUES SWACHHATA PAKHWADA 2025 WITH FOCUS ON CLEANLINESS OF TRAINS AND TRACKS



Ahmedabad, Western Railway is observing Swachhata Pakhwada 2025 from 1st to 15th October, 2025 to promote cleanliness, hygiene, and environmental awareness across stations, offices, workshops, and trains. Building on the launch and initial activities, the campaign progressed with focused initiatives on Swachh Trains, and Swachh Tracks & Yards during Days 6th and 7th.

According to press release issued by Chief Public Relations Officer of Western Railway, Shri Vineet Abhishek, on the sixth day, 6th October, 2025, intensive cleaning and inspection of trains were carried out in primary base rakes and stabled rakes at the washing line with teams of Supervisors and Officers. To encourage cleanliness, awards were declared for best performing contractual supervisors & staff based on zero passenger complaints, as well as best performance. 2 contractual staff were awarded for best performing contractual staff for

best performance and zero passenger complaints. On 7th October, the focus was on Swachh Tracks and Yards. Emphasis was on cleaning of tracks and adjacent area in block section and nearby stations. 80 stations areas were cleaned. Also, cleaning of more than 70 drains alongside the tracks was done. Unwanted grass and bushes were removed along the tracks for maintaining hygiene and

visibility. Urban Local Bodies, State Government representatives, Community Based Organisations (CBOs), Self Help Groups (SHGs), NSS and youth organisations participated and helped in Shramdaan activities and awareness drives to prevent open defecation near tracks. More than 110 km of tracks were cleaned over Western Railway. Western Railway's dedicated commitment and efforts during the Swachhata Pakhwada reflects its strong resolve towards maintaining cleanliness and hygiene ensuring passengers experience in a clean, safe and hygienic environment not only within the station premises but also in the surrounding areas, contributing to overall public health and enhanced travel experience.

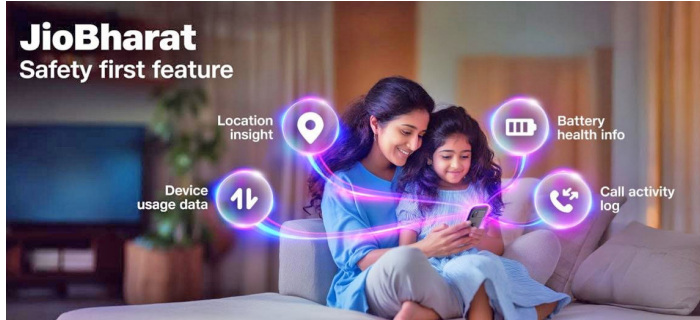
