

DLC Campaign 4.0: Over 55 lakh Digital Life Certificates generated in first 4 days

New Delhi, More than 52 lakh digital life certificates have been generated since the beginning of the nationwide Digital Life Certificate (DLC) Campaign 4.0. On November 1, said Union Minister of State (Independent Charge) for Public Grievances Dr. Jitendra Singh on Wednesday.

Speaking at its formal launch in the national campaign, Singh said that the campaign marks a significant step in the government's drive to simplify life certification for pensioners, especially the super seniors.

"The month-long DLC campaign 4.0, which began on November 1 and will continue till November 30, has already seen over 55 lakh Digital Life Certificates generated within the first four days, against the month-long target of two crore," Singh said.

Campaign 4.0 aims to cover nearly 2,000 districts, cities, and towns across the country through 2,500 camps and coordinated by 1,250 nodal officers.

The initiative adopts a



saturation approach to ensure that every pensioner -- irrespective of location or mobility constraints-- can submit their life certificate seamlessly, said the Ministry of Personnel, Public Grievances and Pensions.

The DLC Campaign 4.0 is being conducted in collaboration with 19 Pension Disbursing Banks, India Post Payments Bank (IPPB), Pensioners' Welfare Associations, UIDAI, MeitY, EPFO, Railways, CGDA, and the Department of Telecommunications, to reach every pensioner across the country, including those in remote and rural areas, the Ministry said.

"This year, special emphasis is being laid on

promoting Face Authentication Technology, developed with full technical support from MeitY and UIDAI, to make the process more seamless and convenient for the elderly," the Ministry added.

Meanwhile, Singh stated that during the DLC Campaign 3.0 last year, 52.73 lakh DLCs were submitted using face authentication, while 72.64 lakh were from EPFO pensioners.

"Campaign 3.0 of last year was conducted in 1,984 locations across 845 districts and cities in November 2024, during which 1.62 crore DLCs were generated, including 49.78 lakh from Central Government pensioners. Of these, over 85,200 were from pensioners above 90 years,

and more than 2,200 were from pensioners aged above 100 years," Singh said.

He noted that the idea behind introducing a Digital Life Certificate was born out of empathy for the elderly.

"It appeared inhuman to ask senior citizens to physically prove that they are alive to receive their pension," he said, adding that the government turned this challenge into an opportunity to introduce biometric and face authentication technologies for a noble cause.

The Minister highlighted that the initiative has evolved into a global success story, with the "unique experiment in governance now being studied internationally".

BJD hits out at Odisha govt on farmer exclusion and Cyclone Montha relief delay

Bhubaneswar, The main opposition Biju Janata Dal(BJD) on Wednesday lashed out at the Bharatiya Janata Party-led Odisha Government, reacting to a letter written by Bargharh BJP MP Pradip Purohit to Chief Minister Mohan Charan Majhi. In his letter, Purohit urged the Chief Minister to include 5,000 farmers from his constituency who were left out of the paddy procurement registration process and also sought compensation for farmers affected by Cyclone Montha.

Speaking to IANS, Senior Biju Janata Dal(BJD) leader and the party spokesperson Lenin Mohanty said the BJD has repeatedly raised concerns over the exclusion of thousands of farmers from the procurement process, which the state government has failed to address.

"It's not just about 5,000 farmers. Thousands across Odisha have been left out due to faulty registration procedures and technical glitches," he stated.

He criticised the government's handling of the paddy procurement and fertiliser distribution system, calling it "harassing and mismanaged."

"Farmers are standing in queues for hours and even days because of poor coordination and technical hurdles. The system needs urgent reform to make it easier for cultivators," Mohanty said.

Taking a dig at the Agriculture Minister, he added, "The Minister seems more interested in promoting dragon fruit cultivation than resolving the plight of lakhs of paddy farmers in western Odisha. The government must immediately include the left-out farmers or face protests."

Haryana Police launch drive to hunt gunmen and absconders; DGP warns, 'surrender or face tough action'

New Delhi, Haryana DGP O.P. Singh on Wednesday launched "Operation Track Down", a statewide police drive aimed at hunting down notorious gunmen, habitual offenders and absconders, and warned those carrying firearms to surrender or face tough legal action. Speaking exclusively to IANS in Panchkula, the DGP said that the campaign was born out of concern that impressionable youth, inspired by films and social-media reels, were glamorising crime.

"They don't realise the consequences of firing a gun — we must tell them this is



not fun," he said. The DGP said the Special Task Force (STF) and district police would jointly identify and target the most notorious faces.

"From each police station, five of the most infamous will be identified, at the district level, 10 such faces, while the STF will track down 20," Singh

said, outlining a phased, 15-day operation.

He added that the STF has compiled a database of roughly 30,000 names, of which around 1,500-2,000 individuals who have fired at least one shot will be prioritised for action.

Singh warned repeat offenders would be booked under organised crime provisions that could keep them behind bars for one to two years without bail. He also said police would seize properties of convicted criminals and house them in government facilities at state expense.

Three Maoists reportedly killed in Bijapur encounter; search operation underway

Raipur, In a fresh flare-up of anti-Maoist operations, security forces in Chhattisgarh have reportedly killed three Maoist insurgents during an ongoing encounter in the dense forests of Bijapur district.

The clash erupted on Wednesday in the Tarlaguda region, near the border of Telangana, where joint teams of police and paramilitary forces are conducting combing operations, police sources said.

While official confirmation is awaited, sources suggest that the bodies of three Maoists have been recovered and weapons seized from the site. The encounter is said to be taking place in the forested stretches between Annaram and Marimalla villages, areas



known for Maoist activity and difficult terrain.

Police teams remain deployed in the jungle, and the operation was still active as of Wednesday evening.

Intelligence inputs had earlier indicated movement of armed cadres in the region, prompting a swift response

from the District Reserve Guard and Special Task Force units.

A statement was issued in the afternoon that "several contingents of security forces are actively engaged in operations in the Bijapur area. At present, the situation is completely normal during the operation. Any information on significant outcome related to the operation will be provided in due course."

Preliminary reports indicate that the Maoists may have belonged to local area committees operating along the inter-state border.

The seizure of arms and ammunition suggests the presence of a well-armed group, possibly tasked with disrupting ongoing development efforts in the region.

This incident comes amid intensified counter-insurgency efforts by both the state and central governments.

Union Home Minister Amit Shah recently reiterated the Centre's commitment to eradicating Maoism from India by March 2026.
