BJP slams Rahul for accusing Govt of targeting Vadra

port for Vadra but also his potential complicity in the alleged wrongdoing. “With his statement, Rahul Gandhi has made it evident that he was fully aware of his brother-in-law’s murky dealings — and perhaps even involved,” Sinha said. The BJP leader also referred to the National Herald case, in which Rahul Gandhi is currently out on bail, alleging that it too involves a suspicious financial trail. “Instead of attributing political motives, Robert Vadra should be answering questions about his modus operandi. And let’s not

forget the National Herald case, in which Rahul Gandhi is on bail, involves a hawala money trail. The Gandhi family owes the country an explanation,” Sinha added.Citing the ED chargesheet, the BJP noted that Vadra’s company reportedly had only Rs 1 lakh at the time of executing the controversial land deal raising questions about how such a transaction was possible without prior political knowledge or involvement.The BJP also hit out at Gandhi’s recent comments made during a public meeting in Assam’s Chaygaon,

where he said that Chief Minister Himanta Biswa Sarma, “who thinks he is a king,” would be jailed by the people of the state for corruption.Calling it a "threat" to a sitting chief minister, Sinha said Gandhi’s remark was not only undemocratic but also displayed a lack of respect for the legal process.“Someone who so brazenly threatens to have an elected Chief Minister arrested, without any legal basis, cannot be expected to respect judicial and investigative institutions,” Sinha said. “There is not a single allegation against Himanta Biswa Sarma.

This kind of rhetoric shows the Congress continues to operate with the same authoritarian mindset it did during the Emergency.”On the issue of alleged political interference in investigations, Sinha also dismissed Congress claims of vendetta in the case involving Bhupesh Baghel’s son, saying that elections cannot be a reason to halt or delay legal proceedings. “Elections happen regularly in India. That doesn’t mean investigating agencies need to seek political approval before acting,” he said.

AP will lead on Green Hydrogen initiatives, says CM Chandrababu

mentioned the successful initiative initiated in 1995, where they began generating power through the reverse pump system at Srisailem to meet high electricity demands. Naidu also

pointed out that the production of green hydrogen could lead to the lowest electricity costs. He drew attention to recent steps taken by the Centre and NTPC towards establish-

ing green hydrogen facilities in Visakhapatnam and announced plans for the development of ports along Andhra Pradesh’s coastline every 50 kilometres.

Govt planning to bring international sporting events to India: Shah

discouraged by defeat, and a child who does not resolve to win after losing never develops the habit of winning. There is only one place to learn — the ground, the playing field — and it is on the playing field that the habit of accepting defeat and the passion to achieve victory are developed. He said that gradually this attitude should develop among our youth". Shah expressed happiness over the Indian contingent winning 613 medals at the 21st World Police and Fire Games and congratulated the Indian police and fire services team for their excellent performance and for making the country proud. He said that the next World Police and Fire Games will be held in India. Shah said, "Our aim should be to ensure that at least one athlete from every police force under the All India Police Sports Control Board participates in the next World Police and Fire Games. Our participation should be inclusive. Each team should aim to win at least three medals. By setting such a goal, the record of winning 613 medals will break on its own". Shah urged the All India Police Sports Control Board to provide world-

class coaches to the Indian police teams and to give specialized training to the medical teams of the forces for treating sports-related injuries. Adding that both these tasks need to be carried out in a planned manner and assured that full support will be provided by the Ministry of Sports. The Home Minister also urged the Directors General of all Central Armed Police Forces (CAPFs) to create an environment where every police personnel and officer develops a sporting spirit. Shah said that today the Indian team was given an incentive amount of Rs 4,38,85,000. He said that earlier, the Police and Fire Games were not given much importance in the country. However, in terms of participation, this is the world’s largest sporting event after the Olympics and the Commonwealth Games. He said, "Last year the Ministry of Home Affairs made several initiatives, including changes in recruitment rules for talent identification, formation of 25 outdoor sports teams in each force, and creating combined teams of the CAPFs. The proposed National Sports Bill

includes a provision to recognize police forces at the state level, enabling each police force to participate as a single unit in national sporting events". Praising the athletes from various police forces for performing well by participating in the Asian Games and Commonwealth Games, Shah said, "Now our focus should be on the World Police and Fire Games - 2029. In the 2029 World Police and Fire Games to be held in Gujarat, every athlete should move forward to win a medal by focusing on a single goal, just like Arjun". Shah said that many members of the Indian contingent won medals at the World Police and Fire Games - 2025, but there were also many who could not achieve success. He said, "The most important thing is to participate in the game; winning and losing are part of life. Setting the goal to win and striving to achieve victory should be our nature, and winning should become our habit. With the habit of winning, we always move towards excellent performance". The Home Minister also lauded Prime Minister Narendra Modi, for

increasing the sports budget fivefold in the past 10 years. "A large number of new sports infrastructures have been developed. Under the TOPS (Target Olympic Podium Scheme), around 3,000 athletes are being supported with a monthly stipend of Rs 50,000 to prepare for the 2036 Olympic Games. The Fit India Movement has also positively impacted the athlete selection process, resulting in a threefold increase in the number of medals won in the Olympics, Paralympics, and Asian Games," the Home Minister said. He expressed hope that India will be in the top five of the medal tallies at the 2036 Olympics. Added that a very positive environment for sports is now developing in the country.

India offers prayers, condolences after Iraq shopping centre fire kills 61

Kut on Wednesday, killing dozens and devastating the local community. According to Iraq’s Ministry of Interior, at least 61 people, including men, women, and children, died in the blaze, and dozens

Moreover, Congress general secretary KC Venugopal too described the Enforcement Directorate (ED) action as a clear case of "political vendetta". On X, Venugopal said, "It seems the Modi-Shah

duo has given the ED a monthly assignment to go after the Congress senior leadership and their family. The latest ED action against Mr Robert Vadra is pure political vendetta - yet another futile attempt at intimidation."

The ED has filed a chargesheet against Robert Vadra in connection with a high-profile land scam in Gurugram, Haryana. The charges pertain to allegations of corruption, forgery, cheating, and

money laundering. Several other individuals and entities have also been named in the chargesheet, including real estate giant DLF and former Haryana Chief Minister Bhupinder Singh Hooda.

The youth from West Bengal are now leaving the state to do even menial jobs,” the Prime Minister said. Speaking on the occasion, Prime Minister Modi further said that the communal riots in minority-dominated Murshidabad district, which allegedly happened under the patronage of a section of Trinamool Congress leaders and individuals from the police administration, are the reason why

the industrialists are scared to invest in the state. “In West Bengal, the police administration always acts in a biased manner in situations like that in Murshidabad. Because of extortion rackets run by the ruling Trinamool Congress leaders, no industrialist wants to invest in Bengal. Trinamool Congress has to go. Otherwise, everything in West Bengal will be in shambles,” the Prime Minister said. He also referred to the brutal rape and murder of a junior doctor of R.G Kar Medical College and Hospital in Kolkata within the hospital premises in August last year and the rape of a law student within her college premises at Kasba in South Kolkata, last month. “Before the entire country could get over the shock of the R.G Kar rape and murder, the rape of a law student within her college premises shook the country again. And in both cases, the ruling party and the administration tried to shield the accused,” the Prime Minister said.

Ashok Gajapathi Raju resigns from TDP

He asked the TDP high command to immediately accept his resignation. To this extent, the resignation letter was sent to TDP National President Chandrababu and State President Palla Srinivasa Rao. Ashok Gajapathi Raju, who won as an MLA seven times and as an MP once, is a senior leader in the TDP. He won as an MLA seven times from the Vizianagaram Assembly constituency and as an MP from the

Vizianagaram Parliament constituency once. Ashok Gajapathi Raju entered politics following in the footsteps of his father PVG Raju. Ashok Gajapathi Raju was first elected to the AP Legislative Assembly in 1978 as a Janata Party candidate. Ashok Gajapathi Raju has been with the party since NTR founded the TDP. Ashok Gajapathi Raju, who contested from the TDP in 1983, was elected to the Assembly for the second time. After that, he won from Vizianagaram in the 1985, 1989, 1994, and 1999 elections. However, Ashok Gajapathi Raju was defeated in 2004. But, in 2009, he contested again from there and won. He also served as a

minister in the joint AP. Ashok Gajapathi Raju, who served as a Union Minister, won from the Vizianagaram Parliament constituency in 2014 and was made the Union Minister of Civil Aviation in the NDA government. He remained as a Union Minister until the TDP pulled out of the NDA in 2018. He contested again from the Vizianagaram Parliament constituency in the 2019 elections and lost by a narrow margin. At the same time, Ashok Gajapathi Raju's daughter Aditi Gajapathi Raju contested from the Vizianagaram Assembly seat and lost. However, Aditi Gajapathi Raju, who contested from Vizianagaram in the 2024 elections, won.
