# On Camera, Last Moments Of Tejas That Crashed In Dubai

**UAE / New Delhi Nov., 21 (UNI):** A Light Combat Aircraft (LCA) Tejas crashed while performing a manoeuvre at the Dubai air show today. People at the event who captured the final moments of the homegrown fighter jet on video posted on social media that they didn't see any ejection. The LCA Tejas that crashed was from a squadron in Tamil Nadu's Sullur, and it was in service since 2016. The small fighter jet attempted a loop manoeuvre by flying

a vertical circle. Within seconds, however, the Tejas slammed the ground before it could gain altitude. A cloud of smoke rose from the crash site. Spectators at the air show, who had been cheering for the homegrown fighter jet, changed from smiles to gasps as they saw what had just happened. The LCA Tejas are the next workhorse of the Indian Air Force (IAF) since the vintage Russian-origin MiG-21 retired recently. IAF LCA Tejas jet crashes & bursts



into flames. The pilot was killed instantly, visuals from Dubai Air Show 25! Tejas is the smallest and lightest aircraft in its class and the dimensions and the exten-

sive use of composite structure make it lighter. In 2016, The first IAF Squadron to induct the Tejas was the No 45 Squadron, the 'Flying Daggers'.

## "Wipe My A\*\*\*": Ex-CIA Man On Pak Apology Demand Over 'India Will Win' Remark

**Islamabad / New Delhi Nov., 21 (UNI):** A controversy has erupted after former CIA officer and whistleblower John Kiriakou revealed that former Pakistan Prime Minister Imran Khan's party, the Pakistan Tehreek-e-Insaf (PTI), tried to coerce him into apologising for comments he made on the conflict between New Delhi and Islamabad. In an intentionally crude reply, Kiriakou wrote that he would use their letter demanding an apology as toilet paper.

Kiriakou made an assessment of the conflict while speaking to ANI in October. He warned that "Pakistanis will lose" and that nothing good will come out of a war between the two countries. "Nothing, literally nothing good will come of an actual war between India and Pakistan because the Pakistanis will lose. And I'm not talking about nuclear weapons. I'm talking just about a conventional war," he said.

His analysis did not sit right with the people of Pakistan as a result of which he received online abuse and death threats.

"I said, in a conventional conflict, India would beat Pakistan because it has five times the people. The death threats... I've lost count of how many death threats I received", he recalled in a YouTube podcast with Julian Dorey uploaded on November 18. Letter condemned his remarks "in the strongest possible terms" and demanded "an immediate apology" to "his excellency, the former prime minister [Imran Khan], to the members of the party [PTI], and to the people of Pakistan." Kiriakou said that the letter had come from the president of the PTI. Former Punjab Chief Minister Chaudhry Parvez Elahi has been leading the party since March 2023. The former intelligence officer



claimed that his lawyer had advised him to "keep a low profile" and to be aware of his surroundings. However, he mailed them back and wrote, "In regards to your demand for an apology, I wipe my a\*\*\* with your demands for an apology." He has not

heard back from the party to date. Kiriakou spent 15 years with the CIA and played a significant role in anti-terror operations after 9/11. He also led the 2002 raid that captured Abu Zubaydah, a high-ranking al-Qaeda official at the time.

## Amid Siddaramaiah vs DK Shivakumar, Congress Slams "Needless Remarks"



**New Delhi Nov., 21 (UNI):** The Congress closed ranks faced with another chapter in the Siddaramaiah vs DK Shivakumar tug-of-war over the Karnataka Chief Minister post. Troubleshotter Randeep Surjewala — who has twice brokered peace between the two leaders — accused the "defeated and faction-ridden" state

unit of the opposition BJP, in collusion with "sections of the media", of running a malicious campaign to weaken the Congress government in the state. "The idea is to undermine stellar achievements of the Congress government... which has become an outstanding model of inclusive development and distributive justice," he said, warning law-

makers backing DKS — a group of whom landed in Delhi Thursday night — against "needless statements".

"The Congress has sternly warned them from making public statements or falling for vested interests' agenda," he said in a post on X, though his next remark raised eyebrows since it seemed to leave the party wiggle room; he said the opinion of party leaders had been 'noted' by the high command. Surjewala's remarks came shortly after DKS seemed to distance himself talk of a 'rebellion' to replace Siddaramaiah, saying, "I am not part of any group... I don't like it and I won't do it." "I have no 'camp' and I am not any

'camp leader' also," he said, referring to a group of Karnataka Congress lawmakers who have publicly called for DKS to replace Siddaramaiah. "For me all 140 leaders (the Congress' 137 MLAs and three independents), are important," he said, also declaring, as he has in the past, that he expects Siddaramaiah to serve out his five-year term.

Siddaramaiah, meanwhile, has made it clear he expects to continue unchallenged. Earlier this week he told reporters, "... my power hasn't gone... it has only gotten stronger. It will continue to remain so... the people voted for us, and we will focus on delivering on our promises."
