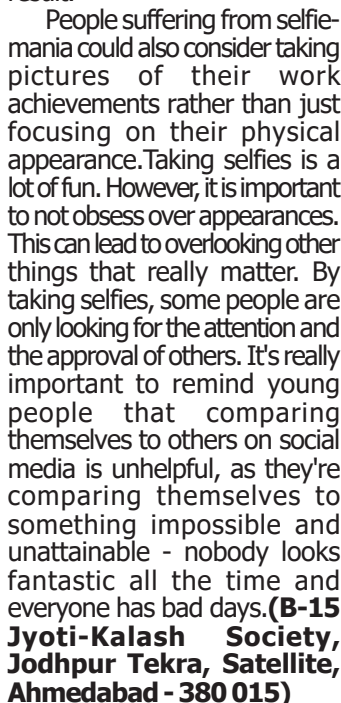

With segments of the army facing stalled promotions while fighting terrorists daily, Munir's future may itself be precarious. A tenured general may retain the sympathy of his troops; a dictator is far more likely to be shown the door.

How Trump's recalibration of US-China ties will affect India

As for Europe, the US also indicated that the EU must be responsible for its own security. In the light of the recent visit of President Putin to India, the US recalibration of Russia makes one point clear — New Delhi does not need to worry about its proximity to Moscow. India, by inviting President Putin, made its foreign policy clear by putting its national interests first and for the world to see, with many analysts debating the western reaction to India's strategic autonomy. But as the US, through its NSS, has done the same, it is less likely that Washington can or should point a finger at India or pressurise it in any way.
