The accused committed suicide by hanging himself by tying a hoodie (sweater) cord to the window in the toilet of the lockup of Panigate police station in Vadodara. Currently, the police have shifted the body to Sayaji Hospital for a panel postmortem. While the sister had said that these people have killed my brother. It is worth mentioning that the wife of a man named Ramesh Vasava, who lives in a house in Jivannagar Wood, filed a complaint against him yesterday (January 20), Ramesh Vasava was detained by the police on the charge of fighting and beating his wife. Following this incident, the police took action under section BNS 176. Currently, the Panigate police has started an investigation into this entire matter.

Can the police detain someone without investigation in family matters?

Can the police detain or arrest in family matters?

Lawyer Jitendra Chandwani said that there are clear directions of the Supreme Court and the law that when there are family matters, business matters or other such civil type cases, then the first thing to do is to conduct a preliminary investigation. Only if the investigation reveals a cognizable (serious) offence, an FIR can be registered and an arrest can be made. Direct arrest or detention in family matters is illegal.

He hanged himself by tying a hoodie sweater string to the window.According to the details received, on January 21, early in the morning, while the 4 accused were sleeping in the lockup, Ramesh got up and at 6.43 am, Ramesh Vasava went to the toilet and came out at 6.48 am by tying a hoodie sweater string to the window to hang himself. He again went to the toilet at 6.49 am, where he committed suicide.

Another accused shouted after seeing Ramesh hanging, after which another accused got up and went to the toilet, where he saw Ramesh hanging, due to which he shouted and the PSO was aware of the incident, due to which the PSO ran to the lockup and informed the PI. After that, the ACP and DCP were also informed, due to which the higher officials also ran.

DCP Abhishek Gupta said that Rameshbhai Vasava was kept in the lockup yesterday (January 20) evening under preventive measures following a petition. Three other accused were also present in the lockup along with him. Early this morning around 6 to 6.15 am, he went to the lockup washroom and hanged himself with the cord of the sweater hoodie he was wearing.

Panchnama will be done in the presence of SDM.

The DCP further said that as soon as this incident came to light, the SDM and ACP have been informed. The investigation is currently underway. Panchnama will be done in the presence of SDM and then a postmortem will be done by a panel doctor. The entire process will be recorded with videography and a legal investigation will be conducted.

Yesterday, on the family's allegation that the accused was beaten 'with a stick' by the police, the DCP said that the body is currently being panchnamaed in the presence of SDM sir and ACP sir. If there are any signs of beating, it will come out in the postmortem report and investigation.

Children's sports equipment and gym equipment have been placed in the gardens of the Municipal Corporation located in different areas of Ahmedabad city. Three years ago, a whopping Rs 6 crore was spent on these equipment in various gardens. Now again, the proposal to spend Rs 10 crore for new equipment in just three years has come under question. This proposal has been approved by the Recreation and Cultural Committee of the Ahmedabad Municipal Corporation, and now it will be approved by the Standing Committee and later by the General Board.

Different agencies have been assigned work in the East and West areas.

Jayesh Trivedi, Chairman of the Creative and Heritage Committee, said that the tender has been approved by the Municipal Corporation's Garden Department for installing new equipment at different places in more than 300 gardens in the city. Contracts have been given to different agencies in both the East and West areas. Wherever the sports and open gym equipment in the garden is dilapidated or broken, new ones will be installed. Equipment like hichka lapsani will be replaced. In the tender that has been issued, 22 different types of new equipment will also be installed.

He further said that three years ago, a tender was approved for installing sports equipment in the eastern and western areas in the same manner. However, the condition of maintenance of the equipment was not kept in it. The condition of maintenance has been kept in this tender so that if any equipment gets damaged, it will have to be repaired by that agency.

Three years ago Rs. 5.73 crore was spent, now 10 crore will be spent.

A large number of people come to the parks in different areas of the city every day. When small children come to play in the parks, the Municipal Corporation has placed open gyms and sports equipment in the parks. Recently, a tender was issued by the Parks Department to place sports equipment and open gyms and equipment for the disabled in different parks of the city. Three years ago, Rs. 5.73 crore was spent and such equipment was placed in different places. The tender process was carried out by the Parks Department.

As many as three



agencies participated in the tender process, of which one agency was controversially disqualified, the reason for which was stated by BJP's Recreation Committee

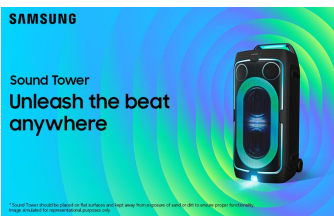
