SJVN'S NATHPA JHAKRI HYDRO POWER STATION CROSSES HISTORIC 150 BILLION UNITS MILESTONE



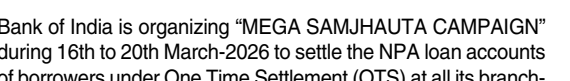
